PRECINCTS AND QUARTERS

14.0 INTRODUCTION

The Central Area contains a number of areas with distinctive character and/or functions. These areas, such as Karangahape Road with its special character and atmosphere, and the commercial port, which has a specialised function and activities, cannot be effectively managed solely by the general rules of the Plan. Special Precincts or Quarters with their own sets of provisions have therefore been created to recognise the distinctions.

The primary characteristics of each precinct or quarter have been identified. These form the basis of resource management issues, objectives, policies and rules for managing the development of the precincts or quarters in a manner which maintains and enhances their particular function and/or character. The specific precinct or quarter provisions complement the higher level resource management issues, objectives, policies and rules which apply to the Central Area.

Each of the precincts or quarters specifies particular rules which apply in addition to, or in place of, the general rules. For example, the architectural form and scale of buildings are identified as key contributors to the sense of intimacy and character of much of the Queen Street Valley Precinct. To maintain and enhance that character, rules on frontage design and frontage height and setback apply to identified parts of the Precinct in addition to the general rule controlling sunlight admission to public places.

The location of each of the precincts or quarters is shown on Planning Overlay Map 1. They are:
