

Significant Ecological Areas have been identified for the Isthmus. These areas comprise the major habitats of indigenous flora and fauna on the Isthmus. The sites are based on extensive ecological survey work carried out across the Isthmus. The sites are identified on the map contained in this appendix.


These sites include identified sites of special wildlife interest together with other significant vegetation features and wildlife habitats. In addition a number of sensitive areas are identified which include cliff associations, coastal edge forests, and potential rated wildlife habitats which are sensitive to development impacts. The following addresses and legal descriptions show which properties are affected. The maps indicate the extent of the Significant Ecological Areas on each property. The addresses and legal descriptions have been obtained from Auckland City's GIS system and from LINZ information. The objectives, policies and rules for Significant Ecological Areas only apply in respect of effects of proposed activities within the area defined as a Significant Ecological Area on the relevant planning map.


