Notice of Requirement a new designation for the Redoubt Road-Mill Road Corridor Project

Notice of Requirement

Auckland Council has received a notice of a requirement from Auckland Transport, as the Requiring Authority, for realignment, widening and improvements to the Redoubt Road-Mill Road Corridor Project described as "construction, operation, maintenance and improvements to the existing Redoubt Road, Mill Road and associated road connections" in Manukau and Papakura, Auckland.

The purpose of the designation is to enable the Requiring Authority to widen and upgrade the Redoubt Road-Mill Road Corridor. The public works are required in order to provide future corridor capacity to support growth identified within the Takanini and wider southern area and provide an alternate north/south corridor to State Highway 1.
