RULE 1

PROHIBITED ACTIVITIES

RULES

1.0 Prohibited Activities

The following activities shall be *Prohibited Activities* throughout the district of Waitakere City:

- (i) the manufacture, production, use, storage and disposal of radioactive material in excess of 10 terabequerel (1×10^{13} Bq)
- (ii) the use of radioactive material for the purposes of power generation or heat generation
- (iii) the extraction of *minerals* in the *Green Network*
- (iv) any area of unvegetated open ground that is not grassed or vegetated with an appropriate ground cover of *vegetation* within 3 months of the completion of *earthworks* activity resulting in that unvegetated open ground.
- (v) the use of waste oil to control *dust*
- (vi) The farming of mustelids, rodents, wallabies and possums.
- (vii) the farming of deer in those Deer Free Areas identified by the Department of Conservation.
- (viii) Any *new dwelling*, school, or hospital within the L_{dn} 65dBA Noise Contour as shown on the 'RNZAF Base - Noise control area' map in the Maps Section.

Any *sign*, (apart from a street number placed in accordance with Bylaw No. 4 Chapter 2 Public Places 1972, Clause 244 as amended,) associated with premises kept or habitually used for the purposes of *Commercial Sex Activities* and/or *Small Brothels* operating a

NOTES

1. If an activity is not controlled or restricted in any way by any part of the *Plan* it is permitted, but may require consents under other legislation/ plans.
2. Activities must comply with all other relevant rules of the *Plan* or be the subject of a *resource consent*. Check all *Human Environment Rules*, the *Natural Areas Rules* and *City-Wide Rules*.
3. Words in *italics* are defined - see the Definitions part of the *City-Wide Rules*.
4. The Council may have a guideline to help interpret this rule - check at the Council Offices.
