
Form 33: Notice of person's wish to be party to proceedings

1. **Alan Moore and WynyardWood Trustee Services Ltd (as the Cory Road Family Trust)** ("CRFT"), wish to be a party to the following appeal [ENV-2009-AKL-323] against the decision of the **Auckland City Council** ("the Council") regarding the **Auckland City District Plan – Hauraki Gulf Islands – Proposed 2006** ("the Proposed Plan") by **Federated Farmers of New Zealand** ("FFNZ").
2. CRFT has an interest in the proceedings that is greater than the public generally as CRFT owns a rural property on Waiheke Island that it proposes to use for planting non-native species (olives, grapes etc) and considers itself and the manner by which it proposes to use its land - affected by this appeal.
3. CRFT is interested in the part of the proceedings with respect to the following issues:
 - a. Provide for the removal of riparian vegetation as a permitted activity [Decision Reference Report 11 6.0(1), Submission Reference 1243/66],
 - b. Provide for the removal of indigenous vegetation less than 3m in height in land units that are used for farming purposes as a permitted activity [Decision Reference Report 28-1 6.0(2), Submission Reference 1243/76]
4. CRFT support the relief sought in the FFNZ appeal for the following reasons;
 - a. The decision of the Council fails to promote the sustainable management of natural and physical resources and is contrary to the provisions of Part II of the RMA,
 - b. The decision of the Council does not support or encourage economic growth and local employment as it restricts the use of horticultural and pastoral land,
 - c. The decision of the Council does not protect CRFT's interests.

I agree to participate in mediation or other alternative dispute resolution of the proceedings.
