PLACE OF RESIDENCE TO BE PUBLIC RECREATION.

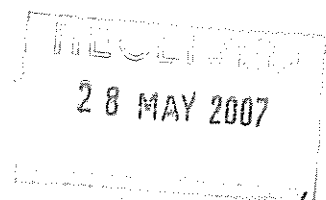
