As you will be aware the above project is the subject of considerable controversy within the Waiheke Island Community. It came up for discussion at the WICPG Annual General Meeting held last Sunday.

The meeting resolved that I write to Council on behalf of the Group on this matter. The Group is of the view that as Library re-development is part of the powers of a Local Board under the most recent Bill of the Super City implementation legislation, community views and wishes should be given greater importance by Council. 
